Our Mission

Our mission is to educate our communities about the destructive impact of litter on our Ocean and waterways and to provide simple, sustainable and effective ways to reduce litter.

Our Approach

Healthy water for all is our end goal. We rely on it for drinking water, food, agriculture and recreational activities, just to name a few. Animals rely on it for survival. Our water - whether it is through waterways or in our ocean - is facing challenges from pollution. This pollution is capable of harming all of us, while also contributing to climate change. We believe that through education and simple daily acts of environmental consciousness, we can get closer to our goal.

Beach Clean-Ups

Each month All One Ocean hosts 2-5 Beach Clean-Ups at local beaches throughout the Bay Area.

We are **unique** from other clean up organizations as we also offer an **educational** component so that all participants walk away with a deeper more meaningful understanding of caring for our Ocean/waterway ecosystems.

Safety

***Please read carefully as All One Ocean is not liable or responsible for any injuries, accidents, fatalities, or incidents that happen at a Clean-Up. Your safety is our top priority so we have provided a few ways to stay safe on the Beach.**

- Wear closed toe shoes with thick soles- there may be sharp or hazardous objects on the beach.
- Always wear your gloves- objects may have bacteria or could be dirty.
- Never pick up a sharp or unidentifiable dangerous looking objects- Alert a facilitator and they will dispose of the item correctly.
- Never go in the water- the currents are very strong and upwelling occurs due to the cold water.
- Do not touch, poke, or disturb sick, dead, or injured organisms- Alert a facilitator of the organism and they will determine what to do.
- Do not take or throw away shells, sticks, or organisms that belong on the Beach. If everyone takes them there will be none left. 😞
- Bring layers! The temperature changes very quickly!
- Wear sunscreen- even on cloudy days.
